1. There will be NO MUSIC PLAYED in any form from any booth, without special written permission from event management. Speakers of any kind are not permitted in any booth. Vendors violating this provision will be removed from the festival. No refund will be given.
2. There will be no sale of guns, ammunition, survival weapons, pepper gas, tear gas, etc.
3. All Food Vendors must provide a ground cover. No ground cover, not setup. All vehicles must be properly disposed of in barrels provided or the vendor will be ejected immediately.
4. All Food Vendors must provide a Safe Serv Certification or Food Permit License to be admitted.
5. No counterfeit merchandise such as knockoff versions of tapes, clothing or other items will be permitted.
6. Vendors participate at their own risk and take full responsibility for all their products and equipment, personal safety, loss and sales. The Atlanta Hip Hop Day is not responsible for any items that are missing or lost from your vending area.
7. All Vendors must be set up and ready for business 30 minutes prior to the start time of the event.
8. All vehicles must be removed from the festival area 60 minutes before the start of the event, or they will be towed at the owner's expense.
